- 7) Having regard to the TREATY OF THE EUROPEAN UNION, with particular reference to Articles 2, 3, 9, 21 and Articles 16 and 17 of the Protocol (No 4) ON THE STATUTE OF THE EUROPEAN SYSTEM OF CENTRAL BANKS AND OF THE EUROPEAN CENTRAL BANK;

unanimously, to fund a non-repayable grant for the *res publica*, or public expenditure (including all salaries of the Public Administration) in favor of the Italian People and as a **substitute for all taxes (cf. point 1., point 5. and point 8)**, for the year 2023, the Republic of Italy, SIC 8888 [foreign governments], business address Ministry of Economy and Finance via XX Settembre, 97 Rome ZIP: 00187, mailing address c / o sasm & f (UK) LLP 40 bank street, Canary Wharf London, governance entrusted to the Italian Government, with the creation *ex nihilo* and the transfer digitized social and humanitarian funds created, for the value, as a first flow and through BANKING AFFIDAVIT, of **€ 666 000 000 000.00 (six hundred and sixty-six Billion, 00 Euros)** which will have to be managed for the common good of the population. 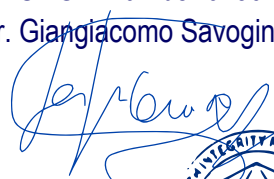

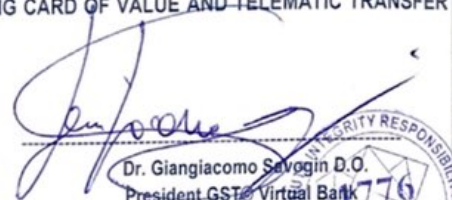
